Dear Registered Interested and Affected Party (I&AP):

**NOTIFICATION: APPEAL DECISION FOR THE PROPOSED TETRA4 CLUSTER 2 GAS GATHERING AND PRODUCTION PROJECT, IN THE VIRGINIA AREA, FREE STATE PROVINCE, SOUTH AFRICA.**

Notice is hereby given that the Minister of Forestry, Fisheries and the Environment has issued a decision (dated 1 August 2024) on the appeals submitted against the Environmental Authorisation granted on 13 July 2023 for the abovementioned project.

A high-level summary of the Ministers decision is as follows:

- The third, fourth, fifth, sixth and seventh grounds of appeal were dismissed.
- The Minister considered new information provided by the appellants and in relation to the first and second grounds of appeal, the Minister deemed it appropriate to remit the application for EA to the Competent Authority (the Department of Mineral Resources and Energy - DMRE) for reconsideration.

The factors that informed the appeal decision on the first and second grounds of appeal will therefore be further investigated by Tetra4, the Environmental Assessment Practitioner and the relevant specialists which will culminate in an updated Environmental Impact Assessment Report (EIAR). Once this process has been concluded, all registered Interested and Affected Parties will be notified of a further 30-day public participation process and opportunity to comment prior to the updated EIAR being submitted to the DMRE for reconsideration.
