NOTICE 2605 OF 2024

**NOTIFICATION REGARDING OPPORTUNITY TO PARTICIPATE IN THE ENVIRONMENTAL APPLICATION PROCESSES FOR THE PROPOSED HARMONY NOOITGEDACHT TAILINGS STORAGE FACILITY PROJECT AND ASSOCIATED PIPELINES, IN MATHJABENG LOCAL MUNICIPALITY, FREE STATE, SOUTH AFRICA.**

Harmony Gold Mining Company Limited (hereafter referred to as the applicant) has appointed Environmental Impact Management Services (Pty) Ltd (EIMS) as the Environmental Assessment Practitioner (EAP) to undertake the necessary environmental authorisation and associated consultation processes. EIMS will compile and submit the required documentation in support of applications for:

- Integrated Environmental Authorisation (EA) and Waste Management License (WML) in accordance with the National Environmental Management Act – NEMA (Act 107 of 1998) as well as the National Environmental Management: Waste Act – NEMWA (Act 59 of 2008); and
- Water Use Licence (WUL) for various water uses in accordance with the National Water Act – NWA (Act 36 of 1998).

The exact activities to be applied for will be confirmed during the process. A full Scoping and Environmental Impact Assessment application process will be followed.

The applicant owns and operates a number of Gold Mines and plants in the Welkom region in the Free State and currently deposits tailings onto the Free State South 2 Tailings Storage Facility (TSF), St. Helena 4 TSF, St. Helena 123 TSF, Dam 23 TSF, Brand D TSF and Target 1&2 TSF. The current planned Life of Mine (LOM) of the Free State operations exceed the available deposition capacity of these TSFs and the applicant is therefore proposing to construct the proposed Nooitgedacht TSF to cater for this additional capacity. The TSF will cover an area of approximately 8.95 km². The proposed TSF will be located on Farm portions Mijannie 66 Ptn 0/RE, Goedgedacht 53 Ptn 0, Nooitgedacht 50 Ptn 0, Jacobsdal 37 Ptn 0 and Rheedersdam 31 Ptn 0.

In addition, three new pipelines are required to be constructed:

- Two 10km long slurry lines from Harmony One Plant to the St Helena Booster Pump Station;
- One 16km long slurry line from Brand A TSF to the St Helena Booster Pump Station; and
- One 17km slurry line from the St Helena Booster Pump Station to FSN 1 TSF.

The pipelines will be flanged steel pipelines of over 0,36m in diameter and installed above-ground on pre-cast concrete plinths and a 3.5m wide access road, adjacent to the pipelines, will be cleared/graded to provide access for construction, maintenance and inspections.

The proposed pipelines traverse the following farm portions: Vlakplaats 125 Ptn 3, 4 and 5; Mijannie RE/66 Ptn 0; Toronto RE/115 Ptn 7 and 0; Rietpan 17 Ptn 0; Rietkuil 28 Ptn 0; Rheeders Dam 31 Ptn 0; Farm 41 Ptn 20; Ouders Gift 48 Ptn 0; Nooitgedacht 50 Ptn 0; Goedgedacht 53 Ptn 0; Theronia 71 Ptn 1 and 7; Jacobsrust 118 Ptn 0; St Helena 42 Ptn 2 and 3, Farm 80 Ptn 0, Stuurmanship 92 Ptn 1, 7 and 0, Saaiplaas 690 Ptn 1, 11, 15 and 0; Klippan 14 Ptn 1, 2 and 15, Marmageli 20 Ptn 0 and 157 Ptn 0.

EIMS will be following the procedures defined in the Environmental Impact Assessment (EIA) Regulations (GRN982 of 2014, as amended) and in the Water Use Licence Application and Appeals Regulations, 2017 (GNR 267 of 24 March 2017) for undertaking a Scoping and Environmental Impact Assessment (EIA) and WULA process. In accordance with Chapter 6 of the EIA Regulations Section 41 of the NWA, a public participation process will be undertaken. You are hereby invited to register and comment on the proposed project and application/s. In order to ensure that you are identified and registered as an I&AP and that your comments are captured, please submit your name, contact details, the reason for your interest or any, in writing or telephonically, to EIMS within 30 days of the publication of this notice. Harmony Gold Mining Company Limited (hierna na verwys as die aansoeker) het Environmental Impact Management Services (Edms) Bpk (EIMS) as die Omgewingsbeoordelings praktisyn (EAP) aangestel om die nodige omgewingsmagtiging en gepaardgaande konsultasie prosesse te onderneem. EIMS sal die vereiste dokumentasie saamstel en indien ter ondersteuning van aansoeke vir:

- Geïntegreerde Omgewingsmagtiging (EA) en Afval bestuurslisensie (WML) in ooreenstemming met die Nasionale Omgewingsbestuurswet – NEMA (Wet 107 van 1998) asook die Nasionale Omgewingsbestuur: Afvalwet – NEMWA (Wet 59 van 2008); en
- Watergebruiklisensie (WUL) vir verskeie watergebruike in ooreenstemming met die Nasionale Waterwet – NWA (Wet 36 van 1998).

Die presiese aktiwiteite waarvoor aansoek gedoen moet word, sal tydens die proses bevestig word. 'n Volledige Omvang- en Omgewingsimpakstudie aansoekproses sal gevolg word.

Die applikant besit en bedryf 'n aantal Goudmyne en aanlegte in die Welkom-streek in die Vrystaat en deponeer tans uitskot op die Vrystaat Suid 2 Uitskot Stoorfasiliteit (TSF), St. Helena 4 TSF, St. Helena 123 TSF, Dam 23 TSF, Brand D TSF en Target 1&2 TSF. Die huidige beplande Life of Mine (LOM) van die Vrystaatse bedrywighede oorskry die beskikbare afsettingskapasiteit van hierdie TSF's en die aansoeker stel dus voor om die voorgestelde Nooitgedacht TSF te bou om vir hierdie bykomende kapasiteit voorsiening te maak. Die TSF sal 'n gebied van ongeveer 8,95 km² dek. Die voorgestelde TSF sal geleë wees op Plaasgedeeltes Mijannie 66 Ptn 0/RE, Goedgedacht 53 Ptn 0, Nooitgedacht 50 Ptn 0, Jacobsdal 37 Ptn 0 en Rheedersdam 31 Ptn 0.
